Terms and conditions

1. General

- 1.1. These terms and conditions shall apply to the Sponsor for the INREV Advanced Tax and Finance and Operations Seminar 2023, arranged by INREV.
- 1.2. Any and all agreements shall be governed by the laws of the Netherlands.
- 1.3. Any and all disputes arising from or in connection with this Agreement, or further contracts resulting there from, shall be settled exclusively by the competent court of Amsterdam, the Netherlands.
- 1.4. If any term of these general terms and conditions or the Agreement is void or nullified, the remaining terms shall remain in full force and effect.
- 1.5. Sponsor's general terms and conditions are excluded.

2. Sponsorship Period

3. Cancellation of Conference
