## **Terms and conditions**

### **1. General**

- 1.1. These terms and conditions shall apply to the Sponsor for the INREV EXPO Real Breakfast 2023, arranged by INREV.
- 1.2. Any and all agreements shall be governed by the laws of the Netherlands.
- 1.3. Any and all disputes arising from or in connection with this Agreement, or further contracts resulting there from, shall be settled exclusively by the competent court of Amsterdam, the Netherlands.
- 1.4. If any term of these general terms and conditions or the Agreement is void or nullified, the remaining terms shall remain in full force and effect.
- 1.5. Sponsor's general terms and conditions are excluded.

### **2. Sponsorship Period**

- 2.1. The sponsorship will be for the period of 5 October 2023, and the promotional period leading up to the event.

### **3. Cancellation of Conference**

- 3.1. INREV shall notify the Sponsor in writing if the event must be cancelled. Notification will be sent by e-mail or by post to the address set out above.
- 3.2. In the event of cancellation by INREV, the Sponsor will be refunded the paid sponsorship fee in full within 30 days of the receipt of such notification.

### **4. Cancellation of Sponsorship**

- 4.1. Once the sponsorship agreement form has been submitted by the Sponsor to INREV, cancellation is no longer possible.

### **5. Force Majeure**

- 5.1. INREV shall not be liable for any failure of or delay in the performance of this Agreement for the period that such failure or delay is due to causes beyond its reasonable control, including but not limited to acts of God, war, strikes or labour disputes, embargoes, government orders, pandemics or any other force majeure event.

### **6. Terms of Payment**

- 6.1. Invoices will be sent to all confirmed Sponsors in August 2023 and payment must be settled within 30 days after receipt of the invoice.
- 6.2. If the Sponsor fails to pay the sponsorship fee within 30 days, INREV reserves the right to cancel the sponsorship agreement and choose another Sponsor.
- 6.3. INREV accepts bank transfer payments only.

6.4. Value added tax (or its equivalent) has not been included in the sponsorship fee but may be applicable depending on local jurisdiction.

## **7. Application Limits**

7.1. Not more than one sponsorship application per INREV membership will be accepted.

## **8. Miscellaneous**

- 8.1. Sponsor is not entitled to assign its rights and/or obligations under the Agreement, or any part thereof, to a third party without the prior written consent of INREV.
- 8.2. The Sponsor shall keep confidential and not disclose any information made available by INREV (“Disclosed Information”) to third parties, unless and to the extent it has a statutory obligation to do so.
- 8.3. All personal data provided to INREV as included in the sponsorship agreement, will be processed for the purpose of executing the sponsorship agreement itself and in accordance with the [Privacy Statement of INREV](#), which can be found on the INREV website.
